Pursuant to Regulation 30 and other applicable provisions of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") read with SEBI Circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 ("SEBI Circular"), we wish to inform you that the board of directors of Sat Kartar Shopping Limited ("the Board" and "the Company", respectively) at its meeting held today i.e. Tuesday, 30th Day of December, 2025, inter alia, has considered and approved:

Acquisition of Assets of Wholly Owned Subsidiary "Ajooni Life Sciences Private Limited"

Ajooni Life Sciences Private Limited, a wholly owned subsidiary of Sat Kartar Shopping Limited ("Company"), has entered into a Asset Transfer Agreement ("ATA") pursuant to which the assets pertaining to the manufacturing activities carried on by Ajooni Life Sciences Private Limited, at sonipat, shall be transferred and vested in Sat Kartar Shopping Limited (Holding Company) for the purpose of carrying the manufacturing in its own name. The said transfer shall take place at Book Value of assets as on December 30, 2025 on the terms and conditions set out in the Asset Transfer Agreement ("ATA"). Details as required under Listing Regulations read with SEBI Circular in relation to Asset transfer is enclosed as **Annexure –A**.
